**HEALTH PERMIT**

**No. 14 CRSPB/22.10.2021**

The Commission for products, materials, chemical substances/mixtures, and equipment used in contact with potable water of the National Institute of Public Health / Bucharest Regional Public Health Center, pursuant to the Technical Evaluation Report no. 14 CRSPB/22.10.2021, decides that the following products that come in contact with potable water can be marketed and used in Romania, in accordance with legal provisions in force.

The products used in contact with potable water:

1.1.The commercial denomination of products used in contact with potable water:

**Multi-layered pipes made of PP-R enforced with glass fiber, “STRONG PIPES” brand.**

1.2.Field of use:

The products are used in the cold potable water supply installation networks (23°C).

1.3.Conditions of use:

- Information regarding the manufacturer and the product's use must be attached upon marketing the product; labeling shall be done in accordance with the legislation in force.
- The Health Permit is given for:

Multi-layered pipes made of PP-R enforced with glass fiber, "STRONG PIPES" brand, a mixture of polypropylene (HOSTALEN PP H5416 – Manufacturer Lyondell Basell Industries Holdings B.V.) with glass fiber insertion, with a ND of 20, 25, 32, 40, 50, and 63 mm for pressures of use of 20 bar (NP20). The layer that comes into contact with the potable water is made of polypropylene colored with masterbatch, in proportion of at least 1% and at most 2%, of a white color (ROMBEST WHITE PP 9507 – manufacturer ROMCOLOR).
